It is not possible to attend online classes immediately after one offline class the college. 8:00-9:00 AM is offline class, and then at 9:00 AM, there is an online class by another faculty, how is this possible?

Sometimes, the online classes are done by requests of a few students, then the other students suffer due to this. Also, this is decided mostly late at night, when a teacher asks on Whatsapp about the next day whether students want an online class. Some students then say yes and the teacher decides the online class for that subject.

Madam, I request your good self to please intervene in the matter and decide the online class well in advance by the faculty. Also, please understand that students are coming from far away and staying at PG and hostels at Delhi. It is very difficult to attend online class at PG and hostels because of sharing rooms, etc, putting earphones for 2-3 hrs for this is not good for the students. My ward is studying at your college and is in a difficult situation because of this online classes.

Hoping that you will be kind to look into the problem and take action madam.







STAFF COUNCIL MEETING (23RD MAY, 2020)

The staff council meeting was convened on 23rd May, 2020 at 11:30 AM, over 'Google Meet' (because of the nationwide lockdown situation), it being the last working day of academic year 2019-20. Following discussion, deliberations and decisions were taken up as per the agenda:

1. T. I. C.s of all the Departments

- a) As per a previous notification on the DRC whatsapp group, all the TICs of the academic year 2019-20 will continue performing their duties as TICs in the academic year 2020-21 as well.
- b) However, matters of certain departments were taken up regarding the above point because of certain unusual circumstances-
 - On the request of Dr. Pooja V. Anand, Dr. Suparna Jain Thakur has taken up in-charge ship of the Psychology Department.
 - ii. Dr. Sangeeta Gupta has been requested to take up in-charge ship of the English Department because Dr. Deepshikha Mahanta expressed her inability to take it up this year.
 - iii.Dr. Sunita is proceeding on leave in this academic session, hence Mrs. Sushma Arora has been requested to take up in-charge ship of the Commerce Department.
 - iv. Dr. Pooja Jain requested to be relieved of her duties as TIC of Sanskrit Department. It was decided that Dr. Sharda Gautam will take up the incharge ship in this academic year.

2. Admission Committee and the sub-committees

- Previous year's (2019-20) Committee with Dr. Sarita Nanda as its convener and Dr. Sujatha Raju as the co-convener have agreed to continue in the said positions.
- ii. Dr. Sonia Mehta will be the convener of B.A. Programme Committee in place of Dr. Suparna Jain Thakur who is now the TIC of Psychology Department.
- iii. Dr. Rekha Kathal requested the chair to relieve her from doing convenorship of Life Science Department during this term due to some personal problems. The Principal asked her to have a mutually agreeable exchange with a member of the Zoology Department.

3. Internal Assessment & Practical Exams

Internal Assessment comprises of two assignments (10 marks each) and attendance (5 marks). The Principal reiterated that in this academic session (even semesters), attendance of the months of Jan., Feb. & 6 days of March would be added to the classes taken up during the lockdown period divided by the total number of classes and multiplied by hundred.

PRACTICAL EXAMS-

Dr. Archana Gupta will be the Superintendent of the practical exams (May - June 2020). All the data regarding the practical exams, i.e., Teachers involved, maximum marks and dates and time of exams is to be submitted by all TICs to her.

It has been advised to all Departments to upload the marks immediately after the exam and its evaluation is completed. 6th June has been fixed up as the last date for uploading these marks.

Dr. Anju Jain, convener T. P. C. informed the house that she would be sharing the minutes of the meeting that had taken place on the 22nd of May, 2020 on I. A. and Practical Exams.

On a question from Dr. Sunita (Commerce) about submission of the soft copy of the students' assignments and practical reports to the college, the Principal advised the Teachers to maintain the record with their own selves and not submit them with the college. She also advised that these records (assignments, etc.) be maintained for a period of 3 years by each teacher.

4. Staff Council Committees

All the Staff Council Committees and its Conveners (2019-20) to continue in the academic session 2020-21 unless a Teacher is retiring or proceeding on leave. The conveners of the following committees ,have however been changed (with effect from 23rd May, 2020).

a) IQAC- Dr. Pooja Jain (IQAC Coordinator) informed the house that as per NAAC Guidelines, IQAC is constituted for a period of 2 years which had now been completed by the present team. Also, as per interest shown by Dr. Sarita Nanda in carrying out the role of Coordinator of IQAC, she was appointed the same by the house.

Dr.Jain also informed the house that members constituting this committee have also completed their tenure and new members need to be appointed.

- b) Student Advisory Board SAB 2019-20 to continue in the year 2020-21 as well. Dr. Pooja Sharma will remain its convener. The Economics Department along with the ad-hoc staff of English Department will constitute this year's SAB.
- Placement Cell From 1st October, 2020 onwards Dr. Kalpana Vaish will takeover the convenership of this committee because Dr. Indu Jain, the present convener, would be retiring.

- d) WDC Dr. Sunita who was the convener of this committee is proceeding on leave, hence keeping this in mind Dr. Anita Mangla has been requested to take up the same.
- e) FIC In light of the fact that Dr. Sunita is proceeding on leave, Dr. Mansi Kanojia will be taking up the convenership of FIC.
- f) SMC Dr. Anita Mangla had requested the chair to be relieved of her duties as a convener of SMC keeping in mind that she had been given the convenership of WDC.

Ms. Haritha would take up the convenership of SMC.

- g) Skill Development Dr. Pooja V. Anand has been asked to continue as the Convener of this Committee.
- h) Alumni Committee Dr. Sonia Mehta will be the Convener of this Committee and Mrs. Sushma Arora will be the Co-Convener.

5. Any other matter -

The Principal informed the house that the last working day for the ad-hoc faculty was 25th May, 2020. She informed that she was still waiting for the directions from the University to be able to grant extension to them. Also, the roster of the teaching faculty will be checked for our college. All ad-hoc teachers who had taken advance from Accounts Department for any committees, etc. need to get a clearance from them.

On a query (from Dr. Sunita) on TA as the component in our salaries for the present month (during lockdown), the Principal informed that the staff is still getting the same.

The house was also informed that the medical bills had already been cleared by the committee comprising Dr. Jyotasana and Dr. Sonika though the payments for the same were still pending.

The meeting ended with a vote of thanks to the Chair.

STAFF COUNCIL MEETING

The staff council meeting was held online on 5thJuly, 2021, at 2.30 pm over Zoom platform.

The following agenda were taken up for discussions & deliberations which resulted in some decisions given below.

1. Confirmation of minutes:

- a) Amendment of corrigenda [A(iii)] Dr. Sunita (Commerce department) requested to be recused of the in-charge-ship of the Commerce department due to medical issues (Covid) that she & her family members were suffering from at that time. Also, that her daughter's under-grad admissions will take place this academic year, clashing with her admission duties. A meeting, convened by Mrs. Sushma Arora (the then T.I.C.) with the principal as special invitee, to this effect, took place. It was decided therein that Dr. Gurmeet Kaur would take over as T.I.C., Department of Commerce for 2021-2022 & that Dr. Sunita would be the T.I.C. in 2022-2023.
- b) Arising out of 'confirmation of minutes' (B)- Dr. Anju Jain requested that it be reported that the matter referred between Dr. Anju Jain & Dr. Jyoti Taneja was 'IPR' matter. Dr. Roy again re-iterated that the matter had been resolved but if all the aggrieved parties were in disagreement again, a committee would be re-constituted. She also emphasized that 'unless proven guilty, the said person cannot be penalized.' And that Dr. Jyoti Taneja would continue as the T.I.C., Department of Zoology. It was even suggested to take up the matter in DRCTA.

2. Formation of the remaining Committees & Societies:

(i) Decisions regarding convenors of various committees & societies was carried out. The members had submitted their names for membership through a google form. An earnest

- effort to have each member in at least two committees was made.
- (ii) The Discipline Committee & the Staff Amenities Committees are in abeyance till the college begins off-line.
- (iii) A new committee, 'Ranking Work Committee' was formed.
- (iv) The principal informed the house that Vidya Vistar is not part of Staff Council since it is a partnership project with another institution. However, the activities related to it to be reported in the council meeting.
- (v) The house was informed that CYBER CELL is not part of staff council.
- (vi) Dr. Archana Gupta (IQAC member) who is collating material on Academic Calendar, 2021-2022, requested the various departments, committees & societies to submit the calendar at the earliest. She also informed the house that only 9 departments had so far submitted the academic calendar.
- (vii) A few members were requesting for letters regarding the staff council decision on extension of T.I.C.-ship, convenorship, membership, etc., which followed the lockdown in 2020. The principal advised the members to keep the staff council minutes regarding this decision for their reference.
- (viii) List of members & the convenors of various committees & societies is attached below.

3. Any other matter:

- (i) A request for an e-mailed copy of salary slips & Form 16 was made to which Dr. Roy informed the house that the work was in progress.
- (ii) A discussion regarding relevance of filling up APAR form by all permanent faculty & bringing about some changes in its format took place. Everyone was however advised that for the ranking of the college, it was important that it be submitted by all.

(iii) Answering a query, Dr. Roy informed the house that the TA for the month of June was paid up but its deduction for the next two months would be done.

 - (iii) Various suggestions as regards collecting information and registration of the Alumni of the college were also made. It was reiterated that efforts should be made to have a larger data base on this aspect with continued updation of progression of students for each department.
 - (iv) The nine faculty members who have been elevated as professors were also given responsibilities (Please refer to the List of Committees).
 - (v) The principal apprised the members about the 'research projects' that can be taken up by the faculty as 'Principal Investigators' (can involve 5 students/ project). It was announced that research proposals will be taken from the faculty and funds will be allocated to the 'accepted' proposals.
 - (vi) A decision regarding the date of the College founder's day and Annual day was made as 3rd March every year.
 - (vii) It was also decided that the College Magazine be published between 20th to 25th Feb. every year.



REPORT OF INTERNAL COMPLAINTS COMMITTEE, DRC

The Internal Complaints Committee of the college, met thrice in the academic session 2022-23, to resolve and address the matter concerning a complaint, wherein, the identity of the complainee as well as the complainant was anonymous and despite this ambiguity, necessary and prompt action was taken and best possible solution was arrived at.

A special sensitisation workshop was organized by the Internal Complaints Committee, on 7th December'2022, for students, teaching and non-teaching faculty, to create awareness on the provisions of "Sexual Harassment at Workplace (Prevention, Prohibition and Redressal) Act, 2013".



The resource person/guest speaker for the event was Ms. Stuti Gupta, Advocate (external member of ICC, DRC). She has completed her graduation in BBA.LLB from Bharati Vidyapeeth University, Pune and has been enrolled with Delhi Bar Association since 2014. She has been practising before Delhi District Courts and Hon'ble High Court of Delhi from last eight years. Currently, she is an External Member of Internal Complaint Committee in M/s Panasonic India, M/s Fuji Films and M/s Industrial Info. She has organised and headed workshops for various companies under Sexual Harassment of Women at workplace and has also conducted online training organised by Ministry of Labour on Women Employment Laws. She has been working with Lex Alliance since 2014 and presently she is associate Partner in the firm. Her area of practise is primarily civil, commercial and matrimonial disputes.




The workshop commenced with a mesmerising lamp lightening ceremony by our esteemed guest Ms. Stuti Gupta, our respected principal madam Dr. Savita Roy, vice principal madam Dr. Sarita Nanda, Dr. Rajni Sahni, Dr. Malini Sharma among the other faculty members. It was followed by a welcome speech given by the Principal of our college. As many as 134 students, 16 members of teaching staff and 3 members of the non-teaching staff were present at the event. Ms. Gupta started the workshop by defining the term 'sexual harassment'. It referred to any unwanted verbal or physical contact that is sexual in nature. She enlightened the audience about different modes of sexual harassment. Few examples included requests for sexual favours, unwelcome and inappropriate promises of rewards in exchange for sexual favours, verbal harassment of sexual nature including jokes referring to sexual acts/ sexual orientation etc. It was surprising to know that sexual harassment can also be online (in the form of bullying, 'sexting', up skirting, etc.). Ms. Gupta also informed the audience about the four laws associated with sexual harassment in India: The Indian Penal code, Sexual Harassment at Workplace Act (POSH Act, 2013), University Grants Commission Regulations (2015) and All India Council for Technical Education Regulations (2015).



She presented the audience with several intriguing examples from the corporate industry and other educational institutions. Her examples included phrases like 'quid pro quo', which mean 'this for that'. It means asking for sexual favours against rewards or punishments if sexual favours are not given. Using examples like this, she made the listeners aware of the importance of sensitization in the society as a whole. According to her, if proper action is not taken against the heinous acts of sexual harassment, it could impact the victim in multiple ways like loss of emotional well-being, physical health, learning; damage to career; bad reputation etc.

She also made the audience aware about the procedure of filing complaints against any act of sexual harassment and how the identity of the complainee should be kept confidential. Furthermore, she also guided on how the Internal Complaints Committee (ICC) should conduct an inquiry if they receive a complaint about sexual harassment in their institution.



Ms. Gupta then emphasised on the responsibilities of Higher Educational Institutions (HEIs) towards spreading the knowledge and awareness about the rights, entitlements and responsibilities enshrined in the POSH Act. The HEIs should organise training programmes, workshops, functionaries to sensitize the students and the faculty members. They must act decisively against all gender based violence perpetrated against employees and students of all sexes including the third gender.

She also alerted the audience about how dangerous it could be to file a frivolous complaint against someone. It may lead to grave problems like spoiling their career, impacting their and family's reputation, acute mental harassment and concerns as critical as committing suicide.



The event was made very interactive by using real life examples and a thought-provoking true or false session. It was then followed by a question and answer session. The workshop concluded with a thank you note by our students. Overall the event was a great success. The participants had an ideal opportunity to learn about a sensitive issue of great importance.







All such grievances were addressed properly and in a timely manner. The complaints also concerned the gateway for paying fees. The problem was reported to the college's administration division, which quickly fixed it. The major grievances were related to the calculation of best ¾ subjects and inclusion criteria of various languages. The grievances were solved on time with the assistance of teacher-in-charges and core committee members.

Applicants raised concerns about the increase in fees associated with the admission process. By kindly informing them of the different scholarships the college offers, the issue was handled. A few complaints also concerned the non-creamy layer certificate and OBC category if listed on the central list. A fair conclusion was made for the situation after consulting the OBC nodal officer (Dr. Sunita K. Yadav). The posting of comprehensive admission requirements on the college website and in the college brochure ensured a smooth admissions process.

Addressing these grievances is paramount to maintaining the integrity and reputation of our college. Hence, timely and informative communication is crucial to alleviate stress and uncertainty for applicants, a policy that the college's grievance committee embraced.




