The Lyngdoh Committee recommendations, the decision of the Hon'ble Supreme Court of India regarding Students' Union Election, within "University of Kerala vs. Council, Principals, Colleges, Kerala and others". The order of the National Green Tribunal of July 18, 2016, Hon'ble Delhi High Court order dated 29-05-2018 in W.P.(C) 7824/2017 titled "Prashant Manchanda Vs. Union of India and Ors. (defacement case)" + W.P.(C) 13538/2024 & CM APPL.56641/2024 titled "AKHILESH KUMAR MISHRA AND ORS" and the Delhi Prevention of defacement of property Act, 2007.
