Subject: Notice Inviting Sealed Quotations for Whitewashing and Painting Work in the Department of Chemistry

Sealed quotations are invited from eligible and experienced contractors/agencies for carrying out **Whitewashing and Painting Work in the Department of Chemistry** at Daulat Ram College, University of Delhi, as per the scope of work and terms & conditions mentioned below.

1. Scope of Work

The work includes, but is not limited to:

- Surface preparation by scraping, rubbing and cleaning the existing walls and ceilings.
- Repair of minor cracks and damaged plaster, wherever required.
- Application of white cement putty on damaged/uneven surfaces.
- One coat of approved quality wall primer.
- Two coats of premium acrylic emulsion paint on walls.
- Whitewashing/painting of ceilings.
- Proper masking, protection of furniture, laboratory equipment, electrical fittings, and flooring during execution.
- Cleaning of the site and disposal of all debris after completion of the work.

2. Approximate Quantity

Particulars	Quantity
Whitewashing and Painting Work	Approximately 10,000 Sq. Ft.

The quantity is approximate and may increase or decrease depending upon the actual site requirement.

3. Eligibility Criteria

The bidder shall:

- Be a registered contractor/firm having experience in similar civil painting works.
- Possess valid GST Registration.
- Possess PAN.

- Have successfully executed similar works in Government Departments, Educational Institutions, Universities, PSUs, or reputed organizations.

4. Time for Completion

The work shall be completed within **15 days** from the date of issue of the Work Order.

5. Terms & Conditions

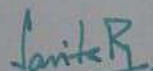
1. The rates quoted shall be **inclusive of all labour, tools, tackles, transportation, scaffolding, loading/unloading, consumables and incidental charges**, but **exclusive of GST**, which shall be payable as applicable.
2. The contractor shall use only approved quality materials conforming to relevant IS standards.
3. The work shall be executed strictly to the satisfaction of the College Engineer/Competent Authority.
4. No advance payment shall be made.
5. Payment shall be released only after satisfactory completion of the work and submission of the bill along with applicable documents.
6. The contractor shall be responsible for the safety of workers and protection of College property during execution.
7. Any damage caused during execution shall be rectified by the contractor at his own cost.
8. The College reserves the right to accept or reject any or all quotations without assigning any reason.
